## Rules

I agree to abide by the following rules of The Pet Motel

## Daycare

Monday to Saturday 8am to 6pm - Sunday Closed

First visit \$45

Further visits \$30

Pre-Paid 10 Day package \$180 (*no refunds for unused days*)

## Overnight Boarding

7 days a week Sunday to Saturday - Check-in and Check-out times 9am to 12pm

Cats \$25.00 per night Small Dogs (1-20lbs) \$25 per night Medium Dogs (21-60lbs) \$35 per night Large Dogs (61lbs+) \$45 per night

Early check in allows your dog most of the day to meet the other pets, exercise and settle before bedtime in a stress free environment.

Check out after 12pm will incur an extra charge at the daycare rate.

**Vaccinations.** The State of Florida requires that a copy of current vaccinations administered by a vet, be provided, prior to boarding or day care services. The following are required after the initial battery of puppy or kitten shots:

1.) Dogs: Rabies, DHPP (distemper/hepatitis/parvo/parainfluenza), and Bordetella.

2.) Cats: Rabies, FVRCP (feline distemper/feline leukemia).

**General Health.** All pets must be in good general health to stay at The Pet Motel. The Pet Motel is not licensed to provide veterinary care. Pets exhibiting signs of illness or injury unfortunately cannot be accepted.

**Fleas / Ticks.** All pets will be checked for fleas and ticks. If parasites are found on your pet they will be treated and the cost added to your bill. Flea/Tick treatment is \$25 to \$30 per pet.

**Behavioral Assessments.** All new dogs are required to pass a temperament evaluation in order to qualify for daycare and boarding services. Unfortunately we are unable to accept pets if they demonstrate signs of significant stress or aggressive behavior towards staff or other animals. If your pet exhibits behavior deemed unsuitable or aggressive, after they have been checked-in, you will be contacted and an extra handling fee of \$15.00 per day/night will be added to your bill.

**Minimum Age.** All pets must be 4 months of age or older.

**Activities.** Your pet will be allowed to socialize, play, and sleep with other dogs of varying sizes and breeds.

**Overnight Accommodation.** We choose the accommodation for each pet, based on their size, breed, age, behavior, and the availability of space, with consideration towards provision of a group sleep setting, unless otherwise specified by the owner.

**Food.** The Pet Motel prefers food for your pet to be provided by you so as to avoid stomach upsets. We do provide premium, grain-free dry food for any pet whose own is either not provided or has run out for an additional \$5.00 per day, per pet. Day care dogs are not included at feeding time, however they may be included for an additional \$5.00 per day, per pet at the owner's request.

All dogs are fed separately unless they are from the same household and we have the owner's permission to feed together.

**Treats.** If you have provided treats they are given at mealtime only. Anything that takes a long time to chew cannot be given.

**Medication.** Details of any medication required by your pet will be given on the medical information form. Complicated or excessive administration of medication may incur an additional fee of \$5.00 per night.

**Bedding.** The Pet Motel provides bedding for all our guests. Any personal bedding must be clearly marked with your pet's name. Unfortunately we are unable to take excessive or oversized bedding.

**Personal Items.** No personal toys or bowls are permitted. Any other items must be clearly marked with your pet's name. The Pet Motel is not responsible for any lost, damaged or forgotten items.

**Medical Attention.** The Pet Motel strives to provide a safe, fun environment for all our guests, however due to the nature of canine social interaction it may become necessary to seek medical care for unexpected sickness or injury. In non-emergency situations, permission for treatment will be sought from the owner or the owner's authorized designee. Emergency treatment will be sought without permission. Any and all costs for medical care will be billed to the owner at check-out.

**Abandoned Pets.** If an owner fails to check out their pet on the agreed date, without making prior arrangements, The Pet Motel may consider such pet/s abandoned. The Pet Motel will comply with all relevant Florida state law with regards to abandoned pets. Any balance on an unpaid bill will be collected through legal means.

## Waiver of Liability. Hold Harmless Agreement

In consideration for receiving permission to participate in the daycare, boarding and grooming services offered by The Pet Motel, I hereby release, waive, discharge and covenant not to sue the Pet Motel, their officers, agents, affiliates or employees (hereafter called "the releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage or injury, including death, that may be sustained by my pet, myself or any property belonging to me, while participating in such service or service related activity, while in, on, or upon the premises where the services and activities are conducted, Regardless of whether such loss is caused by the negligence of the releasees, or otherwise, and regardless of whether such liability arises in tort, contract, strict liability, or otherwise, to the fullest extent allowed by law.

I am fully aware of the risks and hazards connected with the activities of daycare, boarding and grooming and canine social interaction, and I am aware that such services and activities include the risk of injury and even death, and I hereby elect my pet to voluntarily participate in said services and activities, knowing that same may be hazardous to my pet, my property and myself. I understand that The Pet Motel does not require me, or my pet, to participate in this or any other service or activity. I voluntarily assume full responsibility, financial or otherwise, for any risk of loss, property damage, or personal injury, including death, that may be sustained by myself or my pet, or any loss or damage to property owned by me, as a result of being engaged in such services or activities, whether caused by negligence of releasees or otherwise, to the fullest extent allowed by law.

I further hereby agree to indemnify and hold harmless the releasees from any loss, liability, damage or costs, including veterinary costs, court costs and attorney's fees that releasees may incur due to mine or my pet's participation in said services and activities, whether caused by the negligence of the releasees or otherwise, to the fullest extent of the law.

It is my express intent that this Waiver and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive and my heirs, assigns and personal representative, if I am deceased and shall be deemed as a release, waiver, discharge and covenant not to sue the aforementioned releasees. I hereby further agree that this Waiver and Hold Harmless Agreement shall be construed in accordance with the laws of Florida and that any mediation, suit or other proceeding must be filed or entered into only in the state of Florida and the federal or state courts of Florida. Any portion of this document deemed unlawful or unenforceable is severable and shall be stricken without any effect on the remaining provisions.

In signing this agreement, I acknowledge and represent that I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed. No oral representations, statements, or inducements, apart from the foregoing written agreement, have been made. I am at least 18 years of age and fully competent and I execute this agreement for full, adequate and complete consideration fully intending to be bound by same.
